Various activities that can have an effect on the environment may require an environmental permit, certain other permits, a dispensation from the observance of environmental regulations or a notification to the local environmental protection authority. The Environmental Protection Authority of the Municipality of Kirkkonummi has the authority to grant these permits and dispensations and to receive the required notifications. You can apply for most of the permits and dispensations or make the required notifications on the internet through [www.lupapiste.fi](http://www.lupapiste.fi) (website in Finnish and Swedish).

Permits, dispensations and notifications that can be applied for or made through [www.lupapiste.fi](http://www.lupapiste.fi):

- Environmental permit (ympäristölupa)
- Permit to excavate gravel, rock, sand etc from the soil (maa-aineslupa)
- Dispensation from the duty to connect a house to the water main and sewer (vapautus viemäriverkostoon liittymisestä)
- Permit to organise races and training events in terrain for motor vehicles (maastoliikennelupa)
- Permit to alter landscape (maisematyölupa)
- Permit to build or alter a waste water treatment plant on a house (toimenpidenlupa jätevesijärjestelmän rakentamiseen tai muuttamiseen)
- Notification of activities that can cause temporary noise or vibration (meluilmoitus)
- Notification of experimental activities (koetoimintailmoitus)
- Notification of an exceptional situation in an accordance with the Environmental Protection Act 2014 (ilmoitus poikkeuksellisesta tilanteesta)
- Notification of excavation of gravel, rock, sand etc from the soil for domestic use (ilmoitus maa-ainesten kotitarveotosta)
- Notification of dung stockpiles in fields (lannan aumausilmoitus)
- Notification of commercial collection on waste (ilmoitus jätteen keräystoiminnasta)
